1 FRAME

Define the scope and expectations of the project.

2 WASTE DATA REVIEW

3 WASTE AUDIT

We will conduct a waste audit to confirm that the waste data you have provided **accurately represents what is actually happening on site** (often it doesn't!).

We will spot check any issues with **compliance, health and safety, and waste segregation**.

This can be done **in person** or **online**. If online, we may request photos or diagrams.

4 REPORT & RECOMMENDATIONS

Based on the waste data review and waste audit, we will provide a report with our recommendations on **optimisations of equipment, labour, ad-hoc transport and waste costs, compliance, health and safety, reductions in ad-hoc transport and waste costs, as well as opportunities for segregation, recycling, reduction, and innovation**.

Based on our agreed understanding of the scope and expectations, we will include one **life cycle analysis** for the top recommendation.
